Dear Friends and Campers,

The end of another season is drawing near. As always, each of you will have first choice of your current site for next year. If you would like to change sites please let us know immediately. Seasonal sites are permitted **one** camping unit per site without incurring additional charges.

If you are NOT returning for the 2025 season <u>please notify us prior to Oct. 1, 2024,</u> so we may discuss arrangements for removal of your trailer. The site must be vacated by October 20th or daily site fees will apply.

For 2025 our "summer" season will begin May 1st and will end on October 15th.

Please notify us if you are expecting visitors. All visitors must be registered and paid for <u>before going</u> to your campsite. If they are arriving when the office is closed, you must pick up a sign-in form and pay for them in advance.

While non-seasonal sites are limited to no more than six (6) people, seasonal campers are permitted a maximum of eight (8) persons on a site at one time, including yourselves and visitors, without having to rent another site.

Please complete, sign, and return both pages to us with your required minimum non-refundable deposit of \$750.00 by Oct. 1, 2024(or at the time of booking for new customers) to reserve your site. We must have a proof of ownership i.e.: Title or Registration on file, if we do not already have yours on file, please submit one with this letter.

END OF SEASON REMINDERS 2024

IF YOU PLAN TO TAKE A SEASONAL SITE FOR THE FOLLOWING YEAR

A completed seasonal letter with the required minimum deposit needs to be returned to us by Oct. 1st. On October 1st, any site for which we have not received a signed letter with deposit will be offered to those on our waiting list for seasonal sites next year. If we do not have a completed and signed letter with payment, the site must be vacated no later than Oct. 20th or daily site fees apply, and it may be removed from the property as an abandoned vehicle.

REMINDER: You must be paid in full by Feb. 1st in order to receive free winter storage.

WINTERIZING

A winterizing service is offered for seasonals that are taking the site for next year. The fee for winterizing, which includes the antifreeze, will be listed on the seasonal agreement for the next year which will be distributed at the end of the summer (usually around Labor Day). No one will go on the list to be winterized until payment is received. If ordered, or payment is received after Oct. 15th, there will be an additional \$10 charge and we do not guarantee it will be done before it freezes. We start winterizing trailers on October 21st and all trailers will be winterized before the end of the month. You may not cover your trailer until after it has been winterized. We can notify you via e-mail when your unit is winterized. Please remember to leave access to all faucets and drains. Do not pour anything down drains after you have been winterized!

LAST PUMP-OUT FOR 2024

The last pump-out of the 2024 season will be on Monday, Oct 21st. There will be no pump-out available after that week.

WINTER CLEANUP 2024/2025

Please take a good long look at your campsite at the end of the season. You may not wait until next spring to dispose of your old and broken items. Before you close up, please pack away any loose items (lawn chairs, screen tents, ornaments, flowerpots, toys, etc.) Store them in your trailer, a Rubbermaid type shed, or bring them home for the winter. If we are winterizing your trailer, be sure all passageways and access to all faucets and drains are clear. All ropes, strings of lights, feeders, signs, etc., must be removed from trees. All screen rooms, tents, solar lights etc. must be down and stored away. Please remove all coverings from your picnic table, as moisture gets trapped under them over the winter and rots the wood. The last day of the 2024 season is Oct. 20th. All loose items must be packed away by Oct. 20th or they will be thrown out and you will be billed for the time it takes us to clean up your site. Sites should be empty except for the camping unit and the one permitted Rubbermaid storage shed. All trailers must be unplugged from electric on Oct. 20th. Be sure to have all perishable foods removed by then. If you are still at your site or plugged in, off-season camping fees will apply.

OFF SEASON CAMPING

The campground is closed to the public from October 28th to April 25th. Off season camping is only available for the people registered as seasonals for the following season. You may not bring any guests during the off season. You may not spend more than 3 consecutive days at any given time during the off season. If you decide to use your unit after the season has ended, **you must notify us in advance and you must stop in and pay when you arrive.** There is no fee to stop in and check on your unit, however you do still need to call us in advance to check on conditions and stop in at the office when you arrive to let us know you are here. We do not pick up garbage or recyclables during the off season. Please bring them to the dumpster before leaving or take it home with you.

The fee for off-season camping is subject to change each year but is currently:

\$9.00 per night electric

\$11.00 for each adult per night (age 17 and older)

\$3.50 for each child per night (age 2-16)

The water system to all sites will be turned off and winterized on Oct 28th and will not get turned back on until late April. The restrooms (not the shower rooms) at the main office remain open year-round. As most of our electric maintenance and tree removal in the campground is done in the off season, there may be sections of the campground that are inaccessible or without power for extended periods of time. You must call us in advance if planning to camp in the off season to check the status of the electric and access to the site.

Request for Winterizing

If you would like to have your RV winterized by us, this form with the \$100 payment must be received by October 15th. Clayton will start winterizing trailers the week of October 21st and no trailer will be winterized after Oct. 27th, 2024. If this form & payment is not received by Oct 15th, we cannot guarantee you will be winterized before it freezes. Your name will go on the winterizing list only after payment is received. If you are done using your trailer before the season is over and want to be winterized earlier than the week of the 21st please notify us.

Be sure we have all keys to access your trailer and compartments needed for winterizing.

Absolutely no one is permitted on the campground during the six day firearm hunting season from <u>6 pm on the Sunday</u> <u>before to 8am on the Sunday after. NO EXCEPTIONS.</u> Please see the NJ Fish and Wildlife site for exact dates or inquire in the office in the fall.

If you are not returning next season, you must notify us by Oct.1, 2024 and your site must be cleared by Oct. 20, 2024. <u>All trailers</u> that are for sale must be off the premises by the end of the season (Oct. 20th, 2024). Check with your local RV dealer to have your unit removed and sold. The best chance you have of selling a trailer is to put it on an RV dealer's lot.

PLEASE DO NOT DELAY IN MAKING ARRANGEMENTS TO VACATE YOUR SITE IF YOU ARE NOT

RETURNING NEXT SEASON. If you vacate your site after Oct. 20th but before Feb. 1, 2025, you will lose the \$750.00 non-refundable deposit that is due by Oct. 1, 2024 in addition to a \$100/month winter site fee. If your camper is occupying a site after January 31, 2025, and you vacate before April 1, 2025, 1/3 of the seasonal site rate and \$100 per month winter site fee is still owed. If you vacate after March 31, 2025 but before April 25th, half of the seasonal site rate and \$100 per month winter site fee is owed. If you vacate after April 25th, 2025, YOU ARE OBLIGATED TO THE FULL \$600 WINTER SITE FEE PLUS THE FULL 2025 SEASONAL SITE FEES.

If we have to remove your unit and clear the site due to a delinquent account, there will be a \$2500 site clearing fee added to your bill and the trailer will be impounded by the state police as an abandoned vehicle. We are not responsible for any damage to the unit or items inside that may occur if we have to remove your trailer.

If you have any doubts that your circumstances may allow you to return for the 2025 season, we strongly advise clearing your site before Oct. 21, 2024. Weather and ground conditions may prohibit access to sites in the winter and early spring, which could result in a substantial cost to you. If circumstances should change, you could always bring the unit back in the spring.

SPRING FREE CLEAN-UP/FALL FREE CLOSE-UP DAYS

The 2025 season runs from May 1st to October 15th however, seasonals can start opening up their site on April 25th. The water system will be on and flushed by the 25th and there will be no off season fees charged from April 25th to May 1st. In addition, if you are taking the site for the following year, off-season fees will not start in the fall until the night of October 19th.

Please sign and return one copy of seasonal letter and seasonal reminders to the office, along with your required non-refundable \$750.00 deposit for the 2025 season before October 1st, 2024 if you are a returning seasonal. We do have a waiting list of people looking for sites so if we do not have your deposit and letter by October 1st your site may not be available next year.
